



# Terms and Conditions for the African Water and Sanitation International Congress and Exhibition (AfWASA ICE2025) Registration & Payment Platform



## 1. Introduction

These Terms and Conditions ("Agreement") govern the use of the African Water and Sanitation International Congress and Exhibition Registration & Payment platform at <https://www.afwasa2025.org/> and all associated services. By accessing, registering for, or using the Platform, you ("Participant") agree to be bound by these terms. Please read them carefully before registering.

## 2. Eligibility and Registration

2.1. Participants must be at least 18 years old or have explicit permission from a legal guardian to register for the event.

2.2. Registration requires the submission of accurate and complete information. Participants are solely responsible for ensuring the accuracy of the data provided.

## 3. Use of Platform

3.1. Participants agree not to misuse the Platform by submitting false, defamatory, or inappropriate information.

## 4. Privacy and Data Protection

4.1. The Organizers are committed to protecting the privacy and confidentiality of all personal data submitted during registration and use of the Platform. All personal information collected will be processed in compliance with applicable data protection laws.
